## **Drilling Commences at Roe Hills Nickel Sulphide Project**

- MPJ has commenced its next phase of the 2015 drilling programme at the Roe Hills Nickel Sulphide Project consisting of 5000m of RC\Diamond drilling.
- Initial drill holes have been designated to continue the geological definition across all prospects including Talc Lake, Roe 1, Roe 2 and Hooton prior to finalising strategic drill targets on the multiple significant conductors at Talc Lake.
- The MLEM survey as planned with Newexco will continue concurrently in its second stage to evaluate conductive targets at the Roe 1 prospect.
- Sarah Dowling will also commence work to complete detailed geological mapping to provide further accuracy and efficiency to all drill holes.
